PURCHASE AGREEMENT AND SELLING TERMS

Buyer agrees with Frontier Oil Company that all purchases under Frontier Oil Company terms or budget accounts are indebtedness of buyer, and said buyer also agrees to the following:

Frontier Oil Company may make changes in rates, charges and other terms of this agreement from time to time hereafter, provided that buyer is given notice of such changes and they do not exceed the limits established by the law.

If buyer fails to make any payment when due (see terms), Frontier Oil Company may declare the full remaining balance due and payable.

Buyer is subject to court cost after default.

Buyer agrees to the following terms:

The following TERMS will apply to all Frontier Oil Credit sales accounts, with the exception of the Frontier Oil budget accounts:

All credit sales are Net 10 from the date of Fuel delivery or Service callout.

OTHER TERMS:

If buyers account is not kept current, credit terms and automatic deliveries may be suspended without further notice. Accounts in arrears more than 45 days may be turned over to a third party collection agency. Should my account be turned over to collection, I understand I will be billed an administrative surcharge of \$36.00, my credit history will be affected, and I will lose charging privileges with Frontier Oil Company.

I understand a \$25.00 service fee will be imposed for a returned check.

Any fuel deliveries of less than 100 gallons or 50% of the tank's storage capacity, whichever is less, will be charged a minimum delivery penalty of \$5.00.

There will be a surcharge for unscheduled deliveries; this charge will be higher for deliveries made after hours and on weekends. If you have questions about Frontier Oil Company's delivery schedule, call 3 days in advance so you may avoid these additional charges.

CREDIT AGREEMENT:

Frontier Oil will deliver and provide service, subject to availability of product and personnel, at the established Frontier Oil Company price, which is determined at the time of delivery.

CANCELLATION:

Frontier Oil or you may cancel your account at any time on 30 days' written notice. You agree to remain responsible for payment of all purchases made before the 30 day period expires. Frontier Oil also has the right to cancel your account without notice if it is determined to be in default.

DEFAULT AND COLLECTION COST:

You will be in default if you do not pay a balance on time. Default means Frontier Oil can demand immediate payment of the full balance. If Frontier Oil Company refers collection of the balance to a lawyer, you will pay court costs.

LIABILITY:

Frontier Oil Company is not responsible for damage or loss caused by failure to make deliveries due to conditions beyond our control. In the event of default, and if a delivery is not made as a result of default, Frontier Oil Company will not be liable for any damages, either directly or indirectly.

OUTSIDE FUEL TANK OWNERS (Does not apply to Propane):

Due to the unpredictability of winter's temperatures, we must ask that our outside tank owners provide us with directions as to how they want us to proceed with their deliveries as the seasons change. Not only do we need to protect ourselves as the deliverers, but we also need to protect you as the recipients. Nobody wants the aggravation of frozen fuel. For customers with outside tanks requesting #2 Fuel be delivered after October 31st or before March 31st we must have a signature of authorization on file, this authorization must be renewed each year.

#2 FUEL OIL DELIVERY AUTHORIZATION

Outside Fuel Tank Owners

Different home owners have various methods of dealing with the cold temperatures, and therefore we ask that you please review the different scenarios described below, and indicate which applies to you.

- I receive K-1 deliveries year round.
- I receive #2 heating oil during warmer months, and switch over to K-1 during colder months.
- I receive #2 heating oil in my outside tank all year, and
 - I treat my fuel myself to prevent it from freezing.
 - I do not treat my fuel and take full responsibility and hold Frontier Oil blameless should a freeze up occur.

I authorize Frontier Oil to deliver #2 heating oil to my outside tank after October 31st and until further notice. I release Frontier Oil from any liabilities that I might incur as a result of oil freeze ups. (If we need to make a service call to help you with a freeze up, you will be billed accordingly. We cannot make any #2 heating oil deliveries to outside tanks after October 31st through March 31st of each year without having a signature on file giving us authorization.)
